

eGovernment 2020 Roadmap Workshop

Workshop 10a, 09:00, 27th October 2006

Abstract

Recently, eGovernment has evolved towards a recognized research domain. Also, a modern government using innovative information and communication technology (ICT) has become an increasingly important factor of competitiveness and growth in the European knowledge society. In the last years, many EU Member States have revised their existing strategies for public sector modernization and transformation of eGovernment, and they have adapted them to meet the objectives of the EU strategies such as i2010 and the Lisbon agenda. However in most cases, these strategies and activities are short to mid-term oriented.

The eGovernment 2020 Roadmap workshop aims at facilitating an open discussion about the future strategic development of eGovernment and the public sector in 2020 among European experts in the field of eGovernment. The workshop is one of the series of roadmapping workshops of eGovRTD2020 project which is co-funded by the European Commission under the 6th Framework Programme of IST. The resulting research roadmap(s) shall support the implementation of the vision of the European Community: to transform the European Government landscape into a coherent community anticipating customer needs and making use of the available potentials of innovative ICT.

Description

The workshop will be organized as a highly interactive workshop. Workshop participants will have the chance to review and comment the identified gaps of current eGovernment research in respect to potential future of Governments, Society and ICT identified within the eGovRTD2020 project. Workshop participants will discuss and exchange ideas on the potential measures and research actions needed to bridge these gaps. The workshop discussion will be coordinated by several experts in the field of eGovernment around Europe.

Objectives

The objectives of the workshop are to:

- Discuss the gaps of current eGovernment research.
- Identify crucial measurements and research actions needed for reduce the gaps.

- Experts from the different branches impacting eGovernment developments: governments, ICT experts in research and development, consulting, experts from societal fields of competence as well as from organizational and modernization point of view.
